ATC has a retiree program in place that offers benefits. Individual departments may do a celebration and gift at their discretion and own cost.

2. How do you define a "retiree"?



3	Age 55 or older
1	Age 55 or older + 5 years of service
3	Age 55 or older + 10 years of service
1	Age 55 or older + 10 years of service (And age and service points equal 75 or higher)
1	Age 55 or older + 20 years of service

ATC Comment:

ATC defines a retiree as those who have attained age 55 or older and have completed 10 years of service or more with ATC. 3. If an employee has a break in service, do you include the prior service toward the tenure to be classified as a "retiree"?



ATC Comment:

Yes, based on the timing of when the employee termed and is rehired.

What are the parameters for prior service credit? (i.e. All prior service regardless of length of break, prior service if break has been less than a specific period of time, etc.)

# of Responses	Definition
8	All prior service is credited
1	If the employee returns within five (5) years of exiting
1	< 1 year break = counts as continuous service 1-5 years break = service prior to break aggregates with service after the break 5+ years break = service aggregates if vested at the time of termination (vesting is three years)
1	Additional Note: Retirees can defer the start of retiree medical and pension (i.e. They can take another job and then enroll in retiree benefits at a later date).

ATC Comment:

<u>Termination of employee prior to 2010</u>: Employees who left ATC prior to January 1, 2010, and who are then re-employed on or before December 31, 2012, receive credit for prior ATC service for the period of time the employee was considered benefits-eligible.

<u>Termination of employment in 2010 or later</u>: Employees who left ATC on or after January 1, 2010, and who are then reemployed within 12 months of the date of termination, continue to receive credit for service as if no break in service occurred. The employee must have been in a benefits-eligible position when the employ terminated, and they must be reemployed in a benefits-eligible position. 5. Are there any other requirements not mentioned above to be eligible for the retiree program? (i.e. 90-day notice, cannot use vacation to extend service to retirement, etc.)



7	None
2	Cannot use vacation to extend service to retirement
1	Employees hired prior to 8/1/2013 are eligible for retiree healthcare. As of 1/1/2022, the company eliminated the subsidy for retiree healthcare for those who are eligible.
1	6-month notice is required to receive bonus.
1	Must notify by January 15 of year they wish to retire.

ATC Comment:

Cannot use vacation to extend service to retirement.

If hired within the first 6 months of ATC being formed, founding utility service credit is applied to ATC service.

6. What does your retiree program offer?






ATC Comment:

8. Are benefit premiums subsidized by the company?





ATC Comment:

Eligibility for a subsidy varies based on date of hire.

9. What is the subsidy based on? (i.e. length of service, plan type, etc.)

Definition

Subsidy is based on years of service and date of retirement.

Note: Subsidy was eliminated 1/1/2022. Anyone who was hired after 8/1/13 is not eligible for retiree healthcare. Those hired before 8/1/13 and retire after 1/1/2022 have access to retiree healthcare benefits with no subsidy.

Coverage type: \$1500/month family, \$920 employee+1, \$420 Single

100% cost of the employee insurance premium is paid by employer w/20 years of service; at Medicare eligibility employee receives \$350 a month in a HRA to purchase a Medicare supplement plan. employee qualifies for benefits at 10 years but employer contribution prorated.

Subsidized for hourly employees and grandfathered for retirees who started before 2012 for salaried; new hires have access only if 60 and 10 at retirement for pre-65 medical only - no company subsidy

Subsidy is given based on service and if employee was hired prior to 1/1/2005. Subsidy is not offered to employees hired after this date.

ATC Comment:


Age 55 with 10 Years of Service as of July 1, 2010 – Legacy employees:

If the employee came from a founding utility and immediately began employment with ATC between 1/01/2001 and 6/30/2001 all service (ATC & Founding Utility) will be counted in determining eligibility.

Age 55 with 10 Years of Service Hired before January 1, 2010

Employees hired January 1, 2010, or later, who attain age 55 with 10 years of service do not receive a subsidy.

ATC Comment:

ATC's program provides coverage to Pre, and Post-65 retirees.

If the retiree elects, coverage, the retiree's current spouse is also eligible to enroll. (This needs to be the spouse who is married to the retiree at time of retirement.)

If the retiree passes away, coverage for the spouse will end on the last day of the month in which the retiree passed.

13. How long can the retiree spouse remain enrolled in benefits?

2	Until the spouse passes away
1	Until the spouse passes away or gets re-married
3	Until the spouse turns 65

ATC Comment:

If the retiree passes away, coverage for the spouse will end on the last day of the month in which the retiree passed.
